Inter Shielded Metal Arc Welding

COURSE DESCRIPTION

A study of the production of various fillet and groove welds. Preparation of specimens for testing in various positions.

COURSE OBJECTIVES

Upon completion of this course, the student will be able to

1. Select electrodes and amperage setting for various thicknesses of metal and welding positions.
2. Identify principles of arc welding; describe arc welding operations of fillet and groove joints; explain heat treatments of low alloy steels; explain weld size and profiles; prepare test plates; perform fillet welds in the overhead position; perform air carbon arc weld removal; perform groove welds in various positions; and demonstrate use of tools and equipment.
3. Perform SMAW operations in various positions using selected electrodes and different joint designs.

REQUIRED TEXTBOOK AND MATERIALS

Students will not be allowed in class without the proper equipment and clothing

ATTENDANCE POLICY

- Students are allowed to miss three days without penalty; each additional day will result in the student's grade being dropped by a letter grade.

Example:

3 days absent = A drops to a B

4 days absent = B drops to a C

5 days absent = C drops to a D (student must retake class)

6 days absent = D drops to a F (student must retake class)

- I. Absences are counted for unexcused, excused and coming to class late.
- II. 3 tardies = 1 absence
 - A. Tardy- arriving within 15 minutes after class begins or leaving before the end of class.
 - B. More than 15 minutes late you will be counted absent.

- C. If you go to sleep in class you will be counted absent.
- III. **Excused absences.** Only given to allow students to make up missed work.
- A. Will be given for documented Injury or Illness. Doctor's excuse required showing proof. Will count toward total days missed.
- B. Will be given for documented Death in immediate family. Will count toward total days missed.
- C. Approved LIT school functions; E.g. SkillsUSA, SGA etc. Will not count toward total days missed
- D. It is the student's responsibility to obtain from the instructor any handouts or assignments for classes missed. Lectures will not be repeated.
- IV. If you wish to drop, you are responsible for the drop process. I will not initiate the drop, no matter how many absences or zeroes you have; that is, if you stop coming to class and do not drop, you will earn an "F" in the course. Students are only allowed to drop 6 times in their college career.

If you wish to drop a course, you are responsible for initiating and completing the drop process by the specified drop date as listed on the [Academic Calendar](#). If you stop coming to class and fail to drop the course, you will earn an "F" in the course.

STUDENT EXPECTED TIME REQUIREMENT

For every hour in class (or unit of credit), students should expect to spend at least two to three hours per week studying and completing assignments. For a 3-credit-hour class, students should prepare to allocate approximately six to nine hours per week outside of class in a 16-week session OR approximately twelve to eighteen hours in an 8-week session. Online/Hybrid students should expect to spend at least as much time in this course as in the traditional, face-to-face class.
