## **Course Description**

A continuation of Echocariographic Evaluation of Pathology I with emphasis on cardiac disease. A discussion of quantitative measurements and application of 2D, M-mode, Doppler and recognition of the sonographic appearances of cardiac disease is stressed.

## **Course Policies**

- 1. No food, drinks, or use of tobacco products in class.

- 7. <u>Lab Practical Final Exam grade must have a passing grade of 77 or higher to</u> <u>continue in the program. If not, you may have two additional attempts to</u> <u>pass the Lab Practical Final Exam with a 77 or higher. If this is not achieved,</u> <u>you will be given 0% for your OVERALL LAB GRADE resulting in failing</u> the course and the inability to continue in the sonography program.
- 8. All assignments are due when stated. Late assignments will result in a drop of **10** points per late day, and more than five days past due will result in a grade of **0**. If a student has an excused absence with written documentation, assignments will be accepted at the beginning of class upon return. Missed in-class assignments receive a grade of **0**.
