### **Course Description**

Disaster scene control involving large numbers of casualties and fatalities; coordination of the responding agencies. Includes observation and critique of mass casualty disaster drills and critical incident stress debriefing. *This course is time-bound, structured, and completed totally online.*

- 5. Conduct a mock critical incident stress debriefing;
- 6. Explain the importance of critical incident stress debriefings.
- 7. Understand the implementation of Alternate Care Site, Medical Surge and Strategic National Stockpile distribution plans in responding to mass casualty incidents.
