

Composition I (ENGL 1301) Online

Credit: 3 semester credit hours (3 hours lecture)

Prerequisite/Co-requisite: TSI Complete in Reading & Writing

Course Description

Intensive study of and practice in writing processes, from invention and researching to drafting, revising, and editing, both individually and collaboratively. Emphasis on effective rhetorical choices, including audience, purpose, arrangement, and style. Focus on writing the academic essay as a vehicle for learning, communicating, and critical analysis. *This course is time-bound, structured, and completed totally online.*

Course Objectives

- 1. Demonstrate knowledge of individual and collaborative writing processes.
- 2. Develop ideas with appropriate support and attribution.
- 3. Write in a style appropriate to audience and purpose.
- 4. Read, reflect, and respond critically to a variety of texts.
- 5. Use Edited American English in academic essays.

Core Objectives

- 1. Critical Thinking Skills: To include creative thinking, innovation, inquiry, and analysis, evaluation, and synthesis of information.
- 2. Communication Skills: To include effective development, interpretation and expression of ideas through written and visual communication.
- 3. Personal Responsibility: To include the ability to connect choices, actions, and consequences to ethical decision-making.

- The writing process, including pre-writing, drafting, revising, editing, and publishing Grammar, punctuation, spelling, and usage rules
- Modern Language Association, MLA, formatting and citation rules
- Various styles and purposes of writing
- Research methods and source evaluation
