COURSE DESCRIPTION

The course supports students in developing skills, strategies, and reasoning needed to succeed in mathematics, including communication and appropriate use of technology. Topics include the study of numeracy and the real number system; algebraic concepts, notation, and reasoning, quantitative relationships; mathematical models; and problem solving.

COURSE OBJECTIVES

Upon completion of this course, the student will be able to:

1. Use appropriate symbolic notation and vocabulary to communicate, interpret, and

explain mathematical concepts.

2. Define, represent, and perform operations on real numbers, applying numeric

reasoning to investigate and describe quantitative relationships and solve real world

problems in a variety of contexts.

3. Use algebraic reasoning to solve problems that require ratios, rates, percentages, and

proportions in a variety of contexts using multiple representations.

4. Apply algebraic reasoning to manipulate expressions and equations to solve real world

problems.

5. Use graphs, tables, and technology to analyze, interpret, and compare data sets.

6. Construct and use mathematics models in verbal, algebraic, graphical and tabular form

to solve problems in a variety of contexts and to make predictions and decisions.
