## **COURSE DESCRIPTION**

A study of relations and functions, inequalities, algebraic expressions and equations (absolute value, polynomial, radical, rational), with a special emphasis on linear and quadratic expressions and equations.

### **COURSE OBJECTIVES**

Upon completion of this course, the student will be able to

- 1. Define, represent, and perform operations on real and complex numbers.
- 2. Recognize, understand, and analyze features of a function.
- 3. Recognize and use algebraic (field) properties, concepts, procedures (including factoring), and algorithms to combine, transform, and evaluate absolute value, polynomial, radical, and rational expressions.
- 4. Identify and solve absolute value, polynomial, radical, and rational equations.
- 5. Identify and solve absolute value and linear inequalities.
- 6. Model, interpret, and justify mathematical ideas and concepts using multiple representations.
- 7. Connect and use multiple strands of mathematics in situations and problems, as well as in the study of other disciplines.



## **REQUIRED TEXTBOOK AND MATERIALS**

- 1. You are required to buy an access code for MyMathLab for your TMTH 0375 course. You will receive instructions from your instructor. Purchasing an access code is NOT optional. You will need MyMathLab to complete homework assignments, so you will NOT pass this course if you do not purchase an access code for MyMathLab.
- 2. A three-ring binder for keeping and organizing course handouts. Paper, pencils and erasers. Students should have all materials ready to use as soon as class begins. If you do not have your materials ready at the beginning of class, you will be counted absent.
