- b) Failure to deliver by the submittal deadline may not be grounds for disputing the procurement solicitation process or any resulting Contract award.
- c) LIT will not acknowledge or receive bids that are delivered by telephone, facsimile (fax), or electronic mail (e-mail).

- **5. BIDS:** LIT has the option of rejecting any and or all bids.
- **6.  - b) Only those bids that are deemed to be in administrative compliance will be evaluated for responsiveness to State's needs.
 - c) LIT makes no guarantee that an award will be made as a result of this solicitation, and reserves the right to accept or reject any or all offers, waive any formalities or minor technical inconsistencies, or delete and item/requirements from this solicitation or resulting contract when deemed by LIT to be LIT's best interest.
 - d) Representations made within the offer will be binding on responding vendors. LIT will not be bound to act by any previous communication or offer submitted by the firms other than in response to this solicitation.

GENERAL TERMS AND CONDITIONS

LAMAR INSTITUTE OF TECHNOLOGY GENERAL TERMS AND CONDITIONS:

Lamar Institute of Technology (LIT), in compliance with applicable federal and state laws and regulations, does not discriminate on the basis of race, color, national origin, sex, age, religion, disability, handicap, sexual orientation, gender identity or expression, or status as a veteran in any of its policies or procedures. This includes, but is not limited to, admissions, employment, financial aid and educational services.

- 1. COMPLETE AGREEMENT: This Attachment, which is hereby incorporated by reference or attachment and made a part of the Contract and/or Purchase Order, along with any other referenced or attached LIT riders, exhibits, terms, conditions and specifications (collectively, the Contract) constitutes the sole agreement between the parties and supersedes all other writings. Nothing herein shall be construed to be an acceptance of any terms of Supplier. If any provision in the Contract and/or Purchase Order conflicts with these Terms and Conditions the provision contained in these Terms and Conditions shall govern and control.
- **2. MODIFICATION:** No modification of the Contract shall be effective without LIT's prior written consent. No course of prior dealings, no usage of the trade and no course of performance shall be used to modify, supplement or explain any terms used in the Contract. LIT will not be bound by any oral statement, verbal agreement, or other representation contrary to the written specifications, terms, and conditions of the Contract.
- **3. CANCELLATION:** LIT shall have the right to cancel all or any part of the Contract if Supplier breaches any of the terms, conditions, or requirements hereof, or if the Supplier closes its business operations, becomes insolvent or is adjudged bankrupt. Such right of cancellation is in addition to, and not in lieu of, any other remedies which LIT may have at law or in equity.

4. DEFAULT AND TERMINATION:

LIT may terminate the Contract without cause at any time upon thirty days' advance written notice to Supplier, in which event Supplier will be entitled to payment of an amount that will compensate Supplier for any goods accepted or services satisfactorily performed in accordance with the Contract from the time of the last payment date to the termination date; provided, that, Supplier has delivered or performed all such goods or services to LIT for which payment is made. Notwithstanding any provision in the Contract to the contrary, LIT will not be required to pay or reimburse Supplier for any goods delivered, services performed, or expenses incurred by Supplier after the date of the termination notice.

- (a) In the event of a material failure by a party to the Contract to perform in accordance with the terms of the Contract (a default), the other party may terminate the Contract upon thirty days' advance written notice of termination setting forth the nature of the material failure. Termination will not be effective if the material failure is, in LIT's sole discretion, fully cured prior to the end of the thirty-day period.
- (b) If Supplier fails to cure any default within fifteen days of receiving written notice of the default, LIT will be entitled (but not obligated) to cure the default and will have the right to offset against all amounts due to Supplier under the Contract, including but not limited to any and all reasonable expenses incurred in connection with LIT's curative actions.
- (c) Termination will not relieve Supplier or any of its employees, subcontractors, or agents from liability for any default or breach under the Contract, or any other act or omission of Supplier.
- (d) If LIT will make pre-payments to Supplier under the Contract, Supplier will within thirty days of termination of the Contract reimburse LIT all fees paid by LIT to Supplier that were (1) not earned by Supplier prior to termination, or (2) for goods or services that LIT did not receive from Supplier prior to termination.
- **5. DELIVERY & SHIPPING:** All packages and packing lists must reference LIT's Purchase Order Number. Failure to do so may result in the shipment being rejected and/or a delay in payment. Time is of the essence and if delivery of conforming goods or performance of services is not completed by the time(s) promised, LIT reserves the right, in addition to its other rights and remedies, to cancel the Contract, to reject non-conforming goods or services in whole or in

part upon notice to Supplier, and/or purchase substitute goods or services elsewhere and charge Supplier with any losses incurred. If a delay in promised delivery is foreseen, Supplier shall give written notice to LIT, and the delivery date may be extended in LIT's sole discretion.

Supplier must keep LIT apprised at all times of the status of delivery and shipping during the Contract. No substitutions or cancellations will be permitted without prior written approval from LIT. Any provisions herein for delivery of goods or performance of services by installments shall not be construed as making the obligation of Supplier severable. All freight, transportation and handling charges must be prepaid by Supplier. Third party freight bills will not be accepted. **C.O.D. shipments will not be accepted.** Freight is to be F.O.B destination, prepaid and allowed.

6. ACCEPTANCE OF PRODUCTS AND SERVICES: All products furnished and all services performed under the Contract shall be to the satisfaction of LIT as determined by its designated Project Manager and in accordance with the specifications, terms, and conditions of the Contract. LIT reserves the right to inspect the products furnished or the services performed, and to determine the quality, acceptability, and fitness of such products or services.

Any work performed under the Contract will be completed to the satisfaction of the designated Project Manager who will, in all cases, determine, in the Project Manager's sole discretion, the amount, quality, acceptability and fitness of the work that is to be paid for under the Contract. The designated Project Manager will decide all questions that may arise regarding the fulfillment of the Contract by Supplier, and the designated Project Manager's determination and decision thereon will be final.

If the work performed by Supplier does not conform to the requirements of the Contract as determined by the designated Project Manager, LIT, at its sole option, may request Supplier) to re-perform the work at no additional charge to LIT or may request a deduction from the contract price originally mutually agreed upon between Supplier and LIT.

- **7. TITLE & RISK OF LOSS:** Title and risk of loss of goods shall not pass to LIT until LIT actually receives, approves, and takes possession of the goods at the point or points of delivery.
- **8. ASSIGNMENT AND SUBCONTRACTS:** The Supplier's interest in this Agreement Supplier's duties and obligations under this Agreement, and the fees due to the Supplier under this under this Agreement may not be subcontracted, assigned, delegated, or otherwise transferred to a third party, in whole or in part, and any attempt to do so will (a) not be binding on LIT; (b) be a breach of this Agreement for which for which Supplier will be subject to all remedial actions provided by Applicable Laws, including Chapter 2161, Texas Government Code, And 34 TAC Chapter 20, §§20.101 20.108. However, the benefits and burdens of this Agreement are assignable by LIT.
- **9. INDEPENDENT CONTRACTOR:** Supplier shall be an Independent Contractor, and neither the successful Supplier nor any Employee of the Supplier shall be deemed to be an Agent or Employee of LIT. As an Independent Contractor, the Supplier will be solely responsible for determining the means and methods for performing the services described. The Supplier shall observe and abide by all applicable laws and regulations, policies and procedures, including but not limited to, those of LIT relative to conduct on its premises.
- **10. INSURANCE:** The Supplier will carry and will cause its subcontractors to carry, at least the following insurance with companies admitted to do business in the State of Texas and having an AM Best Rating of A-, and in amounts (unless otherwise specified), as LIT may require:

<u>Workers' Compensation Insurance</u> with statutory limits, and Employer's Liability Insurance with limits of not less than:

 Additional Insured, Waiver of Subrogation and 30 Day Notice of Cancellation endorsements are required.

<u>Commercial Automobile Liability Insurance</u> covering all owned, non-owned, leased, or hired automobiles, with limits of not less than \$1,000,000 Combined Single Limit Bodily Injury and Property Damage.

 Additional Insured, Waiver of Subrogation and thirty day Notice of Cancellation endorsements are required.

Additional Insurance Requirements:

- Additional insured endorsements providing Ongoing and Completed Operations.
- Primary and Non-Contributory endorsement required on General Liability.
- Additional Insured and Waiver of Subrogation endorsements must be in favor of: Lamar Institute of Technology, Member of The Texas State University System, their agents, servants, employees, officers, heirs, assigns, successors in interest & representatives in connection with the work.

Coverage Period

- Commercial General Liability Insurance will be kept in force until receipt of Final Payment by LIT to Contractor; and
- Worker Compensation Insurance and Employer Liability Insurance will be kept in force until the work has been fully performed and accepted by LIT in writing;
- If required, Errors and Omissions Insurance will be kept in force an additional two years after the work has been fully performed and accepted by LIT in writing.
- 11. INDEMNIFICATION: Supplier shall and does hereby agree to indemnify, protect, defend with counsel approved by LIT and hold harmless LIT and the Texas State University System, and their respective affiliated enterprises, regents, officers, directors, attorneys, employees, representatives and agents (collectively indemnitees) from and against all damages, losses liens, causes of action, suits, judgments, expenses (including reasonable attorney fees), and other claims of any nature, kind, or description, including reasonable attorney's fees incurred in investigating, defending, or settling any of the foregoing (collectively claims) by any person or entity, arising out of, caused by, or resulting from supplier's performance under or breach of this contract and which are caused in whole or in part by any negligent act, negligent omission, or willful misconduct of supplier, anyone directly or indirectly employed by supplier, or anyone for whose acts supplier may be liable. The provisions of this section shall not be construed to eliminate or reduce any other indemnification or right which any indemnitee has by law. All parties will be entitled to be represented by counsel at their own expense.

In addition, Supplier shall and does hereby agree to indemnify, protect, defend with counsel approved by LIT, and hold harmless indemnitees from and against all claims arising from infringement or alleged infringement of any patent, copyright, trademark or other proprietary interest arising by or out of the performance of services or the provision of goods by supplier pursuant to the contract, or the use by supplier or by indemnitees at the direction of supplier of any article or material; provided that, upon becoming aware of a suit or threat of suit for such infringement, LIT shall promptly notify supplier, and supplier shall be given full opportunity to negotiate a settlement. In the event of litigation, LIT agrees to reasonably cooperate with supplier. All parties will be entitled to be represented by counsel at their own expense.

The indemnities provisions contained herein shall survive the termination of the Contract for any reason whatsoever.

12. NON-DISCLOSURE: Unless required by law or consented to in writing by LIT, no disclosure, description, or other communication of any sort shall be made by Supplier to any third party regarding LIT's purchase of goods or services

hereunder, or of the details and characteristics thereof. Anything furnished to Supplier by LIT pursuant to the Contract, including without limitation, samples, drawings, patterns and materials shall remain the property of LIT, shall be held at Supplier's risk, and shall be returned upon completion of the work. No disclosure or reproduction thereof in any form shall be made without LIT's prior written consent.

13. FORCE MAJEURE: Neither the Supplier nor LIT, shall be liable to the other for any delay in, or failure of performance, of a requirement contained in the Contract caused by Force Majeure. The existence of such causes of delay or failure shall extend the period of performance until after the causes of delay or failure have been removed, provided the non-performing party exercises all reasonable due diligence to perform.

Force Majeure is defined as acts of God, war, strike, fires, explosions, or other causes that are beyond the reasonable control of either party and that by exercise of due foresight such party could not reasonably have been expected to avoid, and which, by the exercise of all reasonable due diligence, such party is unable to overcome. Each party must inform the other in writing with proof of receipt within <u>three</u> business days of the existence of such Force Majeure or otherwise waive this right as a defense.

- **14. GOVERNING LAW AND VENUE:** Jefferson County, Texas, shall be the proper place of venue for suit on or in respect of the Contract. The Contract and all of the rights and obligations of the parties hereto and all of the terms and conditions hereof shall be construed, interpreted and applied in accordance with and governed by and enforced under the laws of the State of Texas.
- 15. COMPLIANCE WITH LAW: Supplier is aware of, is fully informed about, and in full compliance with its obligations under existing applicable federal, state and local laws and regulations, codes, ordinances and orders and with those of any other body or authority having jurisdiction ("Applicable Laws"), including Title VI of the Civil Rights Act of 1964, as amended (42 USC 2000(D)), Executive Order 11246, as amended (41 CFR 60-1 and 60-2), the Vietnam Era Veterans Readjustment Act of 1974, as amended (41 CFR 60250), the Rehabilitation Act of 1973, as amended (41 CFR 60-741), the Age Discrimination Act of 1975 (42 USC 6101 et seq.), Non- segregated Facilities (41 CFR 60-1), Omnibus Budget Reconciliation Provision, Section 952, the Fair Labor Standards Act of 1938, Sections 6, 7, and 12, as amended, the Immigration Reform and Control Act of 1986, and Utilization of Small Business Concerns and Small Business Concerns Owned and Controlled by Socially and Economically Disadvantaged Individuals (PL 96-507), the Americans with Disabilities Act of 1990 (42 USC 12101 et seq.), the Civil Rights Act of 1991, Occupational Safety and Health Act of 1970, as amended (PL 91-596), Immigration and Nationality Act (8 United States Code 1324a) and all other applicable laws. Supplier represents and warrants that neither it nor any firm, corporation or institution represented by it, nor anyone acting on its behalf, (1) has violated the antitrust laws of the State of Texas, Chapter 15, Texas Business and Commerce Code, or federal antitrust laws, or (2) has communicated directly or indirectly the content of Contractor's response to LIT's procurement solicitation to any competitor or any other person engaged in a similar line of business during the procurement process for this Agreement.
- **16. LAMAR INSTITUTE OF TECHNOLOGY PREMISES RULES:** If the Contract requires Supplier's presence on LIT's premises or in LIT's facilities, Supplier agrees to cause its employees, representatives, agents, or subcontractors to become aware of, fully informed about, and in full compliance with all applicable LIT rules and policies, including without limitation those relative to personal health, security, environmental quality, safety, fire prevention, noise, smoking, use of tobacco, access restrictions, traffic, and parking. LIT policies may be viewed at https://www.lit.edu
- **17. ASSIGNMENT OF OVERCHARGE CLAIMS:** Supplier hereby assigns to LIT any and all claims for overcharges associated with the Contract arising under the antitrust laws of the United States, 15 USC 1, or arising under the antitrust laws of the State of Texas, Texas Business and Commerce Code Chapter 15.
- 18. AUTHORIZED TO CONDUCT BUSINESS IN TEXAS AND EXECUTE AGREEMENTS: If Supplier is a corporation or a limited liability company, Supplier warrants, represents, covenants, and agrees that it is duly organized, validly existing and in good standing under the laws of the state of its incorporation or organization and is duly authorized and in good standing to conduct business in the State of Texas, that it has all necessary power and has received all

necessary approvals to execute and deliver the Contract, and the individual executing the Contract on behalf of Supplier has been duly authorized to act for and bind Supplier.

- 19. PAYMENT OF DEBT OR DELINQUENCY TO THE STATE: Pursuant to Texas Government Code Sections 2107.008 and 2252.903, Supplier agrees that any payments owing to Supplier under the Contract may be applied directly to any debt or delinquency that Supplier owes the State of Texas or any agency of the State of Texas, regardless of when it arises, until such debt or delinquency is paid in full.
- **20. NO INDUCEMENT FOR CONTRACT AWARD:** Supplier affirms that it has not given or offered to give, nor does Supplier intend to give at any time hereafter, any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor or service to a public servant in connection with the Contract.
- **21. TAX CERTIFICATION:** If Supplier is a taxable entity as defined by Texas Tax Code Chapter 171, then Supplier certifies that it is not currently delinquent in the payment of any Franchise Taxes due under Chapter 171, or that Supplier is exempt from the payment of those taxes, or that Supplier is an out-of-state taxable entity that is not subject to those taxes, whichever is applicable. A false certification will be deemed a material breach of contract and, at LIT's sole option, may result in termination of the Contract.
- 22. ANTITRUST CERTIFICATION: Supplier certifies that neither Supplier nor any firm, corporation, partnership or institution represented by Supplier, or anyone acting for such firm, corporation or institution, has violated the antitrust laws of the State of Texas, Texas Business and Commerce Code Chapter 15, or the antitrust laws of the United States, 15 USC 1, nor communicated directly or indirectly the proposal made to any competitor or any other person engaged in such line of business.
- 23. TEXAS FAMILY CODE CHILD SUPPORT CERTIFICATION: Pursuant to Texas Family Code Section 231.006 relating to child support, Supplier certifies that it is not ineligible to receive the award of or payments under the Contract and acknowledges that the Contract may be terminated and payment may be withheld if this certification is inaccurate.
- **24. DISCLOSURE OF OWNERSHIP INTEREST OR RELATIONSHIP:** Supplier certifies that (i) no relationship, whether by blood, marriage, business association, capital funding agreement or by any other such kinship or connection exists between the owner of any Supplier that is a sole proprietorship, the officers or directors of any Supplier that is a corporation, the partners of any Supplier that is a partnership, the joint venturers of any Supplier that is a joint venture, or the members or managers of any Supplier that is a limited liability company, on one hand, and an employee of any institution of The Texas State University System on the other hand, other than the relationships which have been previously disclosed to LIT in writing, and (ii) Supplier has not been an employee of any institution of The Texas State University System within the immediate twelve months prior to the submittal deadline, if applicable.
- 25. CERTAIN BIDS AND CONTRACTS PROHIBITED: Supplier represents that it is in compliance with Texas Government Code Section 2155.004, and that no compensation has been received for its participation in the preparation of the requirements or specifications for this Contract. In addition, Supplier certifies that an award of a contract to it will not violate Texas Government Code Section 2155.006, prohibiting LIT from entering into a contract that involves financial participation by a person who, during the previous five years, has been convicted of violating federal law or assessed a penalty in a federal civil or administrative enforcement action in connection with a contract awarded by the federal government for relief, recovery, or reconstruction efforts as a result of Hurricane Rita, Hurricane Katrina, Hurricane Ike, or any other disaster occurring after September 24, 2005. Pursuant to Texas Government Code Sections 2155.004 and 2155.006, Supplier certifies that it is not ineligible to receive the award of or payments under the Contract and acknowledges that the Contract may be terminated and payment withheld if these certifications are inaccurate.

Pursuant to Section 2270.002 of the Texas Government Code, Supplier certifies that either (i) it meets an exemption criteria under Section 2270.002; or (ii) it does not boycott Israel and will not boycott Israel during the term of the contract resulting from this solicitation. Respondent shall state any facts that make it exempt from the boycott certification in its Response.

- 26. - **27. - 28. EXCLUSION FROM GOVERNMENT CONTRACTING: Neither Supplier nor its Principals are suspended, debarred, proposed for debarment, declared ineligible, or voluntarily excluded from the award of contracts from the State of Texas or United States (U.S.) federal government procurement or non- procurement programs, or are listed in the System for Award Management (SAM) from Federal Procurement or Non- procurement Programs (https://www.sam.gov/portal/public/SAM) issued by the U.S. Government. "Principals" means officers, directors, owners, partners, and persons having primary management or supervisory responsibilities within a business entity (e.g., general manager, plant manager, head of a subsidiary, division or business segment, and similar positions). The College strictly complies with all statutes, court decisions, and opinions of the Texas Attorney General with respect to disclosure of Proposal information.
- 33. LOSS OF FUNDING: Performance by LIT under the Contract may be dependent upon the appropriation and allotment of funds by the Texas State Legislature (Legislature) and/or allocation of funds by the Board of Regents of The Texas State University System (Board). If the Legislature fails to appropriate or allot the necessary funds, or if the

Board fails to allocate the necessary funds, then LIT will issue written notice to Supplier and LIT may terminate the Contract without further duty or obligation hereunder. Supplier acknowledges that appropriation, allotment, and allocation of funds are beyond the control of LIT.

- **34. If the dispute cannot be settled by the parties, the parties agree to follow the dispute resolution process in Chapter 2260 of the Texas Government Code.
- **44. ACCESS BY INDIVIDUALS WITH DISABILITIES:** Supplier shall comply with all applicable requirements and provisions of the Americans with Disabilities Act (ADA).

Supplier represents and warrants that the electronic and information resources and all associated information, documentation, and support (collectively, the EIRs) that it provides to LIT under the Contract comply with the applicable requirements set forth in Title 1, Chapter 213 of the Texas Administrative Code and Title 1, Chapter 206, Rules §206.50 and §206.70 of the Texas Administrative Code authorized by Chapter 2054, Subchapter M of the Texas Government Code, United States Rehabilitation Act of 1973 and its amendments, Section 508; and World Wide Web Consortium (W3C), Web Accessibility Initiative (WAI), Web Content Accessibility Guidelines (WCAG) 1.0 and 2.0AA. - **46. - (l) Duration. The restrictions and obligations under this Section will survive expiration or termination of the Contract for any reason.
- **48. RIGHT TO PROTECT INFORMATION RESOURCE SECURITY:** LIT reserves the right to change or modify without consent any information resource, including but not limited to operating systems, hardware, and/or network configuration, in order to protect LIT's Information Resources against any security vulnerabilities and unauthorized access or abuse. Further, if Supplier will provide maintenance under the Contract, Supplier warrants that upon routine maintenance and/or notification by LIT of security vulnerability that such maintenance shall include the installation of operating system and/or application patches and upgrades that will protect LIT's Information Resources against any security vulnerabilities and unauthorized access or abuse.
- **49. WARRANTY AGAINST SPYWARE, MALWARE, AND COLLECTION OF PRIVATE INFORMATION:** Supplier warrants that products purchased by LIT do not contain spyware or malware, and that the products do not collect and/or distribute information that could be considered private without LIT's and the actual users' express consent.
- **50. REMOTE NETWORK ACCESS FOR MAINTENANCE OR REPAIRS:** If Supplier will provide maintenance or repair services under the Contract, access to LIT's information resources for remote maintenance or repairs by Supplier or other authorized vendors shall be limited to use of approved network connectivity access methods such as Virtual Private Network or third party remote dial-up access. - **57. DISCRIMINATION PROHIBITED:** Lamar Institute of Technology and supplier will abide by the requirements of 41 CFR 60-1.4(A), 60-300.5(A) and 60-741.5(A) (collectively, the regulations). The regulations (i) prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities, and (ii) prohibit discrimination against all individuals based on their race, color, religion, sex or national origin. NONDISCRIMINATION:** In their execution of this agreement, all contractors, subcontractors, their respective employees, and others acting by or through them shall comply with all federal and state policies and laws prohibiting discrimination, harassment, and sexual misconduct. Any breach of this covenant may result in termination of this agreement.
- **59. LIMITATIONS:** The parties are aware there are constitutional and statutory limitations on the authority of LIT (a State agency) to enter into certain terms and conditions that may be part of this agreement, including terms and conditions relating to liens on LIT property; disclaimers and limitations of warranties; disclaimers and limitations of liability for damages; waivers, disclaimers and limitations of legal rights, remedies, requirements and processes;

limitations of periods to bring legal action; granting control of litigation or settlement to another party; liability for acts or omissions of third parties; payment of attorneys' fees; dispute resolution; indemnities; and confidentiality, and terms and conditions related to limitations will not be binding on LIT except to the extent authorized by the laws and constitution of the State of Texas.

- **60. APPLICABLE TEXAS LAWS APPLY.** In accordance with Texas Education Code, Section 51.9335 (h), any Contract for the acquisition of goods and services to which an institution of higher education is a party, any provision required by applicable law to be included in the Agreement or Contract is considered to be a part of the executed Agreement or Contract without regard to:
- (a) Whether the provision appears on the face of the Agreement or Contract; or
- (b) Whether the Agreement or Contract includes any provision to the contrary.
- **61. SOVEREIGN IMMUNITY.** Nothing in this Agreement or any attachments hereto shall be construed as a waiver of the constitutional, statutory, or common-law rights, privileges, immunities or defenses of the parties.
